***Legal Cases—Ricci v Greenblatt class action***

*Ricci et al v. Greenblatt et al*, Civil Action No. 72-469-T, (D. Mass. 1972) (class action on behalf of residents of Belchertown State School, seeking injunctive and declaratory relief to redress the state’s alleged failure to provide adequate facilities and care at the state school in violation of federal law and the U.S. Constitution). The complaint is reproduced in Benjamin Ricci, *Crimes Against Humanity: A Historical Record* (New York: iUniverse, 2004), 56–87. The case was settled by consent decree dated November 12, 1973, reproduced in *ibid.*, 336–343. It was later consolidated with similar actions on behalf of residents of other state schools and the consolidated cases were settled by consent decrees dated July 25, 1977; the 1973 Belchertown State School decree was replaced by one of the 1977 decrees. The 1977 consent decrees were supplemented by a further consent decree on personnel dated July 10, 1978. The name of the defendant in the consolidated cases was changed from time to time to reflect changes in the names of the state officials responsible for the state schools.

*Ricci v Callahan*, 97 F.R.D. 737 (D. Mass. 1983) (joining Dept. of Health and Human Services as a necessary party to the class action cases regarding Belchertown State School and other institutions)

*Ricci v Callahan*, 576 F.Supp. 416 (D. Mass. 1983) (authorizing Secretary of Human Services to confront issues of decertification and to withhold matching federal funds from Belchertown State School and other institutions due to non-compliance with Title XIX and the terms of the 1977 consent decrees)

*Ricci v Callahan*, 646 F.Supp. 378 (D. Mass. 1986) (holding that court no longer needed to oversee compliance with 1977 consent decrees remedying unacceptable conditions at Belchertown State School and similar institutions, ordering defendants to continue to provide services in accordance with Title XIX and the consent decrees, and

establishing Office of Quality Assurance to provide independent quality assurance oversight)

*Ricci v Okin*, 537 F.Supp. 817 (D. Mass. 1982) (holding that certain proposed staff cuts at Belchertown State School and other state schools would contravene the consent decrees and Title XIX and limiting reductions at BSS to 9)

*Ricci v Okin*, 1992 WL 163215 (D. Mass. 1992) (granting plaintiffs' motion to extend the term of the Office of Quality Assurance, previously established to oversee implementation of the consent decrees, to the end of 1992)

*Ricci v Okin*, 1992 WL 175509 (D. Mass. 1992) (denying defendants' motion to stay the court's order of June 24, 1992 extending the life of the Office of Quality Assurance to the end of 1992)

*Ricci v Okin*, 823 F.Supp. 984 (D. Mass. 1993) (closing the federal court's oversight of the 21-year-old class actions regarding Belchertown State School and the other state schools, and supplanting and replacing the consent decrees with a court order specifying the continuing services to be provided to members of the plaintiff class)

*Ricci v Patrick*, 544 F.3d 8 (1<sup>st</sup> Cir. 2008) (reversing district court and dismissing claims by plaintiffs to reopen the case and order the Department of Mental Retardation to take certain actions)

*Boyd v Board of Registrars of Voters of Belchertown*, 368 Mass. 631 (1975) (holding that BSS residents who were never declared incompetent or placed under guardianship were not ineligible to vote)

*Brunson v Wall*, 405 Mass. 446 (1989) (affirming lower court judgment dismissing employment and racial discrimination claims by Belchertown State School employee)

*Case of Chartier*, 19 Mass.App.Ct. 7 (Hampden Co. 1984) (affirming lower court judgment that former Belchertown State School employee's salary at BSS should not be taken into account for purposes of calculating amount of workman's compensation due as a result of an accident at another job that occurred after employee terminated his employment at BSS)

*Com. of Mass. v Chapin*, 333 Mass. 610 (1956), *cert. denied*, 352 U.S. 857 (1956) (affirming the qualifications of Belchertown State School Superintendent Tadgell to testify as a mental expert, in a murder trial, regarding defendant's ability to distinguish right and wrong)

*Com. of Mass. v Daniels*, 366 Mass. 601 (1975) (setting aside murder conviction against former Belchertown State School resident and ordering new trial because of State's failure to present evidence to aid trial court to evaluate the impact of custodial interrogation on ability of mentally retarded defendant to understand his rights during an interrogation in which he confessed to the crime).

*Com. of Mass. v Heckler*, 616 F.Supp. 687 (D. Mass. 1985) (holding that certain habilitative services being provided at Belchertown State School and similar institutions, such as teaching residents to signal for food when ready to eat, were eligible for reimbursement under Medicaid), *affirmed in part and vacated in part*, 816 F.2d 796 (1<sup>st</sup> Cir. 1987), *cert. granted*, 484 U.S. 1003 (1988), *judgment affirmed in part reversed in part*, 487 U.S. 879 (1988).

*Com. of Mass. v Maillet*, 400 Mass. 572 (1987) (affirming conviction of Belchertown State School attendant for second degree murder of local gas station employee), *new trial denied*, 36 Mass.App.Ct. 1123 (1994), *review denied*, 418 Mass. 1105 (1994), *second motion for new trial denied*, 56 Mass.App.Ct. 1112 (2002), *review denied*, 437 Mass. 1111 (2002).

*Com. of Mass. v Phoenix*, 409 Mass. 408 (1991) (affirming the conviction of a Belchertown State School employee for murdering his supervisor, the school's



power plant facility manager), *denial of habeas corpus affirmed by Phoenix v Matesanz*, 233 F3d 77 (1<sup>st</sup> Cir. 2000).

*Guardianship of Bassett*, 7 Mass.App.Ct. 56 (Hampshire Co. 1979) (addressing certain technical questions from the Probate Court in relation to a petition filed by the superintendent of Belchertown State School seeking to appoint the Friends Association as guardian of a BSS resident's person and estate)

*In re Surrender of Minor Children*, 344 Mass. 230 (1962) (holding that a former resident of Belchertown State School had lawfully and voluntarily surrendered her four children for adoption)

*Kenny v Boston & M.R.R.*, 301 Mass. 271 (1938) (denying claim by attendant at Belchertown State School against railroad for injuries sustained as passenger in an automobile that collided with train operated by defendant while attendant and driver were searching for an escaped state school resident)

*Pomeroy v Dept. of Public Welfare*, 3 Mass.App.Ct. 177 (Hampden 1975) (affirming denial of certain welfare payments to mother of Belchertown State School resident for support of the resident)

Cellucci*, 1999 WL 34815562 (1999) (granting motion for class certification by certain former residents of state schools in Massachusetts including Belchertown State School seeking declaratory and injunctive relief on behalf of themselves and a class of persons with mental retardation and developmental disabilities because of their alleged unnecessary commitment to and inappropriate confinement in nursing homes), *motion to dismiss denied*, 52 F.Supp.2d (231 (1999).

*Rolland v. Cellucci*, 191 F.R.D. 3 (D. Mass. 2000) (approving settlement of claims by former state school residents now in nursing homes)

*Rolland v. Cellucci*, 138 F. Supp.2d 110 (D. Mass. 2001) (finding substantial noncompliance by the state with the 2000 settlement agreement with former state school residents now in nursing homes)

*Rolland v. Cellucci*, 198 F.Supp2d 25 (D. Mass. 2002) (granting plaintiffs' motion to obtain specialized services individually tailored to address their needs while confined in nursing homes), *affirmed* 318 F.3d 42 (1<sup>st</sup> Cir. 2003)

*Rolland v. Patrick*, 562 F.Supp.2d 176 (D. Mass. 2008) (amending earlier settlement agreement with former state school residents now in nursing homes so as to provide for community placement for most such residents not yet placed), *affirmed* 592 F.3d 242 (1<sup>st</sup> Cir. 2010)

*Superintendent of Belchertown State School v Civil Service Commission*, 9 Mass.App.Ct. 756 (Suffolk 1980) (holding that the superintendent of Belchertown State School, in dismissing the school's chief power plant engineer, was allowed to take into account a proved charge against the engineer of unethical conduct (taking a bribe) even though the incident occurred three years prior to the discharge)

*Superintendent of Belchertown State School v. Saikewicz*, 373 Mass. 728 (1977) (holding with respect to a mentally incompetent Belchertown State School resident who was suffering from leukemia that such resident's legal guardian could properly decide on the resident's behalf not to take chemotherapy)
