This report covers the period October 1, 2009, through June 15, 2010, the effective date of the termination agreement. The sections of this report include: activities during this period; management, financial, and technical reports submitted; and a list of reports to be submitted.

#### **Technical Activities**

During this period, the evaluation team worked on the overall evaluation design; baseline questionnaire development; case studies design and development; and conceptualizing and initiating the literature review. The overall design document was submitted to Twaweza on April 7, 2010. In addition, the team facilitated three workshops held in Dar, presented at the Board meeting, and worked on building collaborative partnerships with the University partners and on-going discussions with two survey research firms.

#### **Baseline Questionnaire Development**

The team developed the conceptual framework for the questionnaires, including research and evaluation questions and preliminary hypotheses; this document was submitted to Twaweza on April 7, 2010. With input and commentary from OPHI and Twaweza, the team drafted and conducted preliminary field testing on the household questionnaire, facilities questionnaires (school and health facilities), and the community questionnaire. Drafts of these questionnaires were submitted to Twaweza on May 25, 2010. The draft questionnaires submitted included:

- Household questionnaire
- School Facilities Questionnaire
- Pupil Literacy Assessment & Enumerator Guidebook for Pupil Assessment
- Community questionnaire
- Health Facilities questionnaire

### **Case Studies Design and Development**

The team developed a preliminary design for the baseline and subsequent case studies. A report on this design was submitted to Twaweza on April 19, 2010.

### **Literature Review Development**

Working with our consultant, the team framed out, conceptualized, and began research, policy documents, and other documents relevant for the literature review.

### **Workshops**

The team developed and facilitated three workshops in Dar. These included:

- Baseline survey workshop – February 16-19, 2010
- Overall design workshop – May 12-14, 2010
- Case studies workshop – May 15-16, 2010

In addition, Ash Hartwell presented on the overall design to the Board on April 23, 2010.
