Call for Papers: Afro-Ásia Journal

Announcement by Afro-Ásia journal of the Federal University of Bahia and the Harriet Tubman Resource Center on the African Diaspora.

Founded in 1965, Afro-Ásia is a quarterly publication of the Center of Afro-Oriental Studies (CEAO) of the Federal University of Bahia in Salvador, Brazil (UFBA). It publishes articles on issues related to African and Asian populations and their descendants in Brazil and elsewhere. Afro-Ásia is one of the few Brazilian publications fully dedicated to African and Afro-Brazilian studies, in a country and state (Bahia) where Africa's vital role in history and culture is widely known. The work published in Afro-Ásia has promoted academic debate on such issues as the history of slavery, racial relations or the complex processes of identity construction, and has also been crucial in informing a progressive socio-political agenda in the fight against ethnic and racial inequality in Brazil. Beginning in 2005, the printed edition of the journal will be supplemented by an electronic version.
