Heated discussion erupted over the American Historical Association statement urging universities to allow PhD recipients to embargo their electronic dissertation for up to six years while they pursue a book contract. Harvard University Press responded with a blog post that made a convincing case that immediate open access could be advantageous. Some institutions have recently changed their open access and embargo policies. This panel will provide faculty, librarian, University Press, and graduate student views on this timely topic followed by Q&A.

Access to existing research data is fundamental to the research process. A panel of researchers will talk about the ways they use the data gathered by others, and the obstacles to data access and re-use.

- Thomas Herndon, Graduate Student in Economics. His work has “sparked an academic and political firestorm over one of the most famous economic papers in decades, and over whether austerity or stimulus is the best route to long-term prosperity” says the Boston Globe.
- Irene Boeckmann, Graduate Student in Sociology. Boeckmann is a PhD candidate in the sociology department. Her research interests include gender, parenthood, labor market stratification, social policies and welfare states, and cross-nationally comparative analyses. Currently, she is working on her dissertation examining the employment patterns of women after the transition to motherhood from a comparative perspective. She works with Professors Joya Misra and Michelle Budig on their research project studying the relationship between the women's employment outcomes and work-family policies across 22 countries in Europe, North America and Australia.

Suspending any judgment regarding distinction between theory and practice, this forum encourages critical reflections on communication and seeks to encourage these reflections to and among those who place communication at the center of their thinking and writing.
- Journal of Medicinally Active Plants <http://scholarworks.umass.edu/jmap/> facilitates scholarly exchange among those studying and/or interested in medicinally active plants and plant extracts. The Journal publishes scientific manuscripts related to the analysis, application, bioactivity, collection, conservation, cultivation, growth, harvest, identification, physiology, processing, and other issues related to medicinally active plant material.
- New England Conference for Student Success <http://scholarworks.umass.edu/studentsuccess/> . Now in its 4th year, this conference focuses on a wide variety of themes central to student success.
