He has edited *Level Three: A Black Philosophy Reader* and is editor of the *New England Journal of Black Studies*, an organ of the Regional National Council of Black Studies.

DORRANCE JAMES HILL is presently pursuing an MFA at the University of Massachusetts, Amherst, and a Ph.D. at New York University in art. He has exhibited both in one man and group shows, at the Augusta Savage Gallery, the Hampton Gallery and Whitmore Administration Building of UMass. Further, his work has been shown in the Invitational Gallery of the New England Artist Festival and showcase held in Northampton, Massachusetts where in 1981 he was artist in residence and special exhibitor. He has lately been invited to show at the Leverett Artist and Craftsman exhibit in Leverett, Massachusetts.
